

# NASHVILLE EMERGING LEADER AWARDS

### INDUSTRY DESCRIPTIONS

Each applicant should apply under one industry category. Some individuals will be eligible to fit under multiple categories, but you must choose the category you feel best fits your job responsibilities.

The descriptions below are to be used as a guide to help you choose the best industry for your application and in no way will cause an applicant to be disqualified from the NELA. The NELA program manager reserves the right to move your application to another industry. In the event this happens, the applicant will be contacted.

#### **ARCHITECTURE, ENGINEERING & CONSTRUCTION**

Any individual whose business or primary job responsibilities are in the fields of architecture, engineering or construction.

## ARTS, ENTERTAINMENT AND MUSIC BUSINESS

Any individual whose business or primary job responsibilities are in the music business (business or creative), the entertainment industry and visual or performing arts. This industry also includes sports related jobs.

### **BUSINESS SERVICES**

Any individual whose has demonstrated innovation, efficiency, and exceptional service delivery, enhancing the operations and success of businesses across various industries.

## **COMMUNITY SERVICE AND NONPROFIT**

Any individual whose business or primary employment is with any organization working for the improvement of the Nashville community, including non-profit and not-for-profit organizations.

## **EDUCATION**

Any individual whose business or primary job responsibilities focus on the educational developmentand well-being of the Nashville area, such as teachers, School Board members, principals and vice principals, coaches, education committee members, etc.

## **ENVIRONMENT AND SUSTAINABILITY**

Any individual whose business or primary job responsibilities focus on the environment or other areasof sustainability and green jobs.

#### **ENTREPRENEURSHIP**

Any individuals who exhibit exceptional vision and leadership in founding and growing successful small businesses

### **FINANCIAL SERVICES**

Any individual whose business or primary job responsibilities are in the field of financial services such as accounting, banking, insurance, loan officers, financial planners, mortgage brokers, etc.

#### **GOVERNMENT AND PUBLIC AFFAIRS**

Any individual whose business or primary job responsibilities focus on the development of governmentor its agencies. This includes any individual working for the State of Tennessee, a local government, armed services, police officers, firefighters, etc.

#### **HOSPITALITY AND TOURISM**

Any individual whose business or primary job responsibilities are focused on Nashville's hospitality and tourism industries. These individuals may be employed by restaurants, hotels, retail stores, museums, nightclubs, etc.

### **HUMAN RESOURCES**

Any individual whose business or primary job responsibilities relate to human resource functions in theareas of HR management, recruiting, training and development, benefits, etc.

## **LEGAL SERVICES**

Any individual whose business or primary job responsibilities focus on Tennessee state law. This industryis not exclusive to lawyers, but also includes any individual supporting the law such as paralegals, court reporters, judges, etc.

## MEDICAL AND HEALTH CARE SERVICES

Any individual whose business or primary job responsibilities focus on the health care industry, providing medical attention to patients, sales of medical supplies, pharmaceuticals, etc. This includes both healthcare providers and administration.

## PUBLIC RELATIONS, ADVERTISING AND MARKETING

Any individual whose business or primary job responsibilities are focused on the public relations, advertising and/or marketing aspects of an organization.

## **REAL ESTATE SERVICES**

Any individual whose business or primary job responsibilities are in the field of buying and selling realestate, either commercial or residential.

### **TECHNOLOGY**

Any individual whose business or primary job responsibilities focus on the technology needs of anyorganization.

## **WELLNESS**

Any individual who is advancing wellness through physical, mental and emotional well-being within communities and organizations.
